

LAWRENCE UNIVERSITY ACADEMIC ACTION GUIDELINES

At the end of each term, the Faculty Subcommittee on Administration reviews the academic records of all students according to the university's academic action guidelines. These were approved by the faculty on April 20, 1990, and amended for senior students on January 16, 1998.

Full-time students are expected to progress toward graduation as follows: At the end of the freshman year, or three terms, a student should have completed at least 48 units and have a minimum degree GPA of 1.833. At the end of the sophomore year, or six terms, a student should have completed at least 102 units and have a minimum degree GPA of 2.000. All other students are required to maintain a cumulative degree GPA of 2.000 to remain in good academic standing. Students who do not meet these guidelines, receive failing grades, or display other indications of unsatisfactory progress may be warned, placed on academic probation, suspended, or required to withdraw from the university.

Any student who is required to withdraw may apply to the Faculty Subcommittee on Administration for readmission after one full academic term of absence. Petitions for readmission should address the issues that led to academic dismissal, describe what the student has done to resolve those issues, and provide a plan for ensuring academic progress upon the student's reinstatement. In most cases, students applying for readmission must, at a minimum, demonstrate satisfactory academic performance at another college or university. Only students who present a strong and compelling case will be readmitted.

Students who are suspended may return to campus without petitioning but will be on strict probation at the time of return.

Students placed on strict probation may not participate in either extracurricular performances or sports (varsity, junior varsity, club) nor may they hold a position of responsibility, elected or volunteer, in any LUCC-sanctioned activity or Greek organization. The spirit of this eligibility restriction is to limit any significant extracurricular activity, but not necessarily to eliminate nominal participation, such as attendance at a meeting.

Students placed on probation or strict probation may not participate in off-campus study programs sponsored by Lawrence, the Associated Colleges of the Midwest, or other organizations with which Lawrence has consortial agreements.

The Faculty Subcommittee on Administration, at its own initiative, may grant exceptions to its requirements for good academic standing based on special circumstances.
