Financial Planning (core service)

The Vice President for Development or designee will join the Committee for conversations regarding the impact of philanthropy on our operating budget. The President or a designee will chair the Committee.

Sustainability

Tenure, Promotion, Reappointment, and Equal Employment Opportunity (core service)

Institutional Animal Care and Use

Members: Membership is constituted to be in compliance with the guidelines established by the National Institutes of Health, Office of Laboratory Animal Welfare (OLAW), and to include Lawrence staff who are

responsible for the maintenance of the animal facilities: one practicing Lawrence University faculty scientist experienced in research with animals (will serve as chair), this is the only position that counts as a faculty service assignment; one staff person who is involved in the daily operations of the animal care facility from each department utilizing vertebrates in teaching and/or research; one veterinarian with training or experience in laboratory animal science and medicine, who has direct or delegated authority and responsibility for activities involving animals at the institution; one member whose primary concerns are in a nonscientific area (e.g., ethicist, lawyer); one member who is not affiliated with the institution other than as a member of the IACUC.

Institutional Review Board (IRB)
